AUDIT EXECUTIVE SUMMARY:

This inspection and the total time spent included 3 farms (growing areas), four harvesting crews and one packinghouse facility. This Farm/ farming evaluation included the review of the growing activities involved in the production of conventional vegetables, which includes the growing area, the ground history & adjacent land use, the handling of chemicals -both for nutritional and pest control-, the quality of the water used for fertigation, irrigation, pesticides application and hand washing -when used from the in-house water sources-, the hygiene of the field workers and sanitary facilities. This Farm has approximately 521 Acres total in 5 production areas: 26-2, N 60 Ac. for cantaloupes (2 blocks: A-B, 42 and 18 Ac. each); 26-2, S 26 Ac. honeydews; 26-3, 150 Ac. (3 blocks: A-C, 80, 40 and 30 Ac. each; 9-1, 151 Ac. cantaloupes/ honeydews (5 blocks: A-B 38 Ac. each for cantaloupes, and A-C, 38, 19 and 19 Ac. each for honeydews); and 9-4, 134 Ac. cantaloupes/ honeydews (4 blocks: A 20 Ac. honeydews, A-C 34, 38 and 38 Ac. each for cantaloupes). The growing area can be irrigated with on-site wells and the district water system from the San Luis Reservoir (underground pipeline) using the drip irrigation system. This year the district water was used. There was observed irrigation activities today.
